## DEADLINE: April 1, 2024

Join us on this artistic expedition as we emphasize not only the significance of Sustainable Development Goal 11: Making cities and human settlements inclusive, safe, resilient, and sustainable but also the crucial role of cooperation among sister cities. Let your imagination soar as you shape the vision of a climateresilient future strengthened through collaboration and solidarity among urban communities worldwide!

## Medium & Specifications:

- Media accepted in this category include oil, acrylic, watercolor, charcoal, colored pencil, crayon, ink, marker, etching, collage, etc. For digital medium artwork, see a separate application.
- Only two-dimensional (2D), unframed artwork will be accepted.
- Dimensions of the art and matting must not exceed 24 in. x 36 in or 61 cm. x 91.5 cm.
- Use of copyrighted or trademarked images is prohibited.
- Entries must not be plagiarized, stolen, or copied from any other source. Entries must not defame or invade the rights of any person, living or dead.
- All entries must be supported by matting if applicable.

Entries:

• Each participating student artist must be between 13 and 18 by April 1, 2024. All entries must be the original design and artwork of the entrant. Only new pieces inspired by the theme should be submitted. When describing their artwork in the application form, students are encouraged to discuss how their local communities and international cities are approaching this year's theme. Students can talk about collaborative efforts between communities, give project examples, or explore areas of potential cooperation within the Agricultural field.

• Students must submit their artwork at Franklin City Hall Mayor's office by April 1, 2024.

## Awards:

Local Competition: First, second, and third places will be chosen, and cash prizes will be awarded to the students. 1st place will receive \$100, 2nd place - \$75; and third place - \$50. The winning student's teacher will receive \$250 from Franklin Sister Cities for art supplies.

International Competition: First, Second, and Third place winners will be selected in the international competition in Washington, D.C. The Grand Prize Winner (1st place) will receive \$1,000; 2nd place will receive \$250; and 3rd place will receive \$100. The winning art pieces will be published on the Sister Cities International website.
